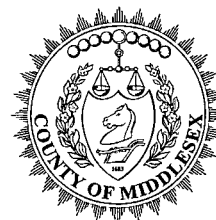

WHEREAS, pursuant to N.J.S.A. 40A:11-1 et seq., the Board of County Commissioners of the County of Middlesex is authorized to advertise for bids for the performance of any work or the furnishing of any materials or supplies or services; and

WHEREAS, in response to advertisements, the Purchasing Agent received bids on August 29, 2023 for the Furnishing and Delivery of Snowplow Parts, as required by the Middlesex County Department of Transportation, Office of Public Works (Bid No. B-23-034); and

WHEREAS, the Purchasing Agent advises that the Bid Specifications, under 6.5 Method of Award, state the following:


BE IT FURTHER RESOLVED that the Contract shall commence from on or about October 25, 2023 for a period of twelve (12) consecutive months. Any services ordered or made within thirty (30) days after the contract expires shall be under the same terms and conditions specified in the bid and contract prices submitted by the vendor, unless said vendor indicates, in writing, thirty (30) days prior to Contract Expiration, that it will not be bound by said terms, conditions and contract prices;

BE IT FURTHER RESOLVED that the award of Contract to said vendor shall be and is hereby made subject to the receipt and approval of vendor documents by the Office of County Counsel; and

BE IT FURTHER RESOLVED that, in the event said vendor documents are not received and approved by County Counsel on or prior to the date of the award of contract, the award of contract shall be rescinded and awarded to the next responsible bidder at the next public meeting of this Board; and

BE IT FURTHER RESOLVED that the bid bonds or checks of the three (3) lowest bidders shall be returned to them within three (3) days, Sundays and holidays excepted, after the awarding and execution of the contract and approval of the performance bond or other security; and

BE IT FURTHER RESOLVED that a certified copy of this resolution be forwarded to the Various Vendors listed above.


